The European Union has amended the European long-term investment funds (ELTIF) regulation as of January 10, 2024, making it significantly more attractive for investors and fund providers. The ELTIF 2.0 is, for instance, more flexible, easier to access – including for private (retail) investors, no longer requires a minimum subscription amount, is more cost-transparent, and benefits from tax advantages in some European countries such as Luxembourg. The ELTIF 2.0 vehicle offers a diverse range of investment opportunities. Assets with a capitalised earnings value due to their nature and characteristics, such as infrastructure projects (e.g. in the area of renewable energies), real estate and corporate investments, are now eligible investments.

The INTREAL Group offers its clients the option to launch ELTIFs via INTREAL Luxembourg. INTREAL Luxembourg has been licensed by the Luxembourg Financial Supervisory CSSF as independent AIFM (Alternative Investment Fund Manager) and central administrator with focus on real estate and infrastructure funds as well as private debt funds and fund of funds for these asset classes. 
