Solutions successfully completes SAP S/4HANA transformation for 350 funds

- ◆ The project involved the data of INTREAL Luxembourg, INTREAL, HIH Invest, an external KVG mandate and nine mandates from the KVG services

INTREAL Solutions has migrated around 350 funds and over 450 real estate companies to the modern SAP S/4HANA platform. The transformation was completed in just two and a half years, significantly improving the efficiency and scalability of the systems. Such transformation projects can otherwise take up to five years for large companies take up to five years. SAP S/4HANA is an ERP software that companies can use to cover and control their daily processes – from marketing to accounting, from logistics to human resources and procurement.

The project included the migration of the data of the capital management companies (KVGs) of INTREAL Luxembourg, INTREAL, HIH Invest, nine external management company services mandates and another external management company mandate. The changeover required a complete system conversion of the existing ERP system SAP ECC 6.0 to S/4HANA in the SAP private cloud. The changeover means that additional functions can now be used, including the new loan management (CML), the business partner component (BP), the modern asset accounting (FIAA) and SAP Fiori apps.

Andreas Ertle, Managing Director of INTREAL and INTREAL Solutions, emphasizes the strategic importance of the project: "With this successful migration, we have created the technical basis for the next 10 to 15 years. This milestone shows that the INTREAL Group continuously invests in future-proof technologies to be able to serve as a stable partner to its customers over the long term."

The biggest challenge was the migration of the long-term data history. In this process, data from the last ten years had to be transferred in the form of cumulative account balances and open items. To ensure data quality, a quality offensive to clean up and consolidate the data sets was carried out in advance, particularly for business partners and loan agreements.

Particular attention was also paid to the existing IT ecosystem. All connected applications were seamlessly integrated into the new platform. This required extensive testing for both new and existing functions.
